1. *Date of Hearing*

On Nov 25, 2015 the Court heard this case.

2. *Appearances*

Petitioner, MICHAEL TODD TRLICEK, appeared in person and through attorney of record, STEPHANIE J. PROFFITT, and announced ready for trial.

3. *Jurisdiction*

The Court, after examining the record and hearing the evidence and argument of counsel, finds that it has jurisdiction of this case and of all the parties and that no other court has continuing, exclusive jurisdiction of this case. All questions of fact and of law were submitted to the Court. All persons entitled to citation were properly cited.

4. *Record*


The record of testimony was duly reported by the court reporter for the County Court of Galveston County.

6. *Eligibility for Adoption*

The Court finds that the parent-child relationship has been terminated as to [REDACTED] a parent of the child, and as to each living alleged or probable father whose paternity has not been adjudicated. The Court further finds that the child is at least two years old. The Court further finds that Petitioner has been a managing conservator for at least six months.

7. *Residence with Petitioners*

The Court finds that the child has lived in the home of Petitioners for at least six months.

8. *Social Studies*

The Court finds that the required preadoptive and postplacement social studies have been waived.

9. *Health, Social, Educational, and Genetic History Report*

The Court finds that the preparation and filing of the health, social, educational, and genetic history report concerning the child has been waived by this Court. The requirement of submission of the report to the child's adoptive parents is waived.

10. *Criminal History Record Information*

The Court finds that the criminal history record information required for MICHAEL TODD TRLICEK and MEKISHA JANE WALKER is on file in the record of this case.

11. *Interstate Compact*

The Court finds that Petitioners have filed a verified allegation or statement regarding compliance with the Interstate Compact on the Placement of Children as required by section 162.002 of the Texas Family Code.

The Court finds that the parent with existing parental rights has consented to this adoption by written consent on file in this case.

12. Adoption Granted

The Court finds that all prerequisites and requirements for adoption have been met and that the adoption is in the best interests of the child. IT IS ORDERED that the adoption of the child the subject of this suit by Petitioners is GRANTED and that the parent-child relationship is created between the child and Petitioners for all purposes.

IT IS FURTHER ORDERED that the name of the child the subject of this suit is changed to GRACE ELIZABETH WALKER.

13. Report Transmitted; Files Sealed

IT IS FURTHER ORDERED that the clerk of this Court shall, after entry of final orders in this case, transmit to the Vital Statistics Unit at Austin, Texas, a certified report of adoption in accordance with section 108.003 of the Texas Family Code. All papers and records in this case, including the minutes of the Court, are ordered sealed.

14. Relief Not Granted

IT IS ORDERED that all relief requested in this case and not expressly granted is denied.




